# UCU Donation Application Category 2: for Requests of \$500 to \$2,500

#### **General Instructions**

- All requests must be submitted on an official UCU application form. It is preferable that the application is filled out and submitted electronically, however if you are not able to do so, please print out an application and fill it out by hand.
- General correspondence that does not indicate a requested dollar amount will not be considered for donations or sponsorships
- Ukrainian Credit Union Limited will not provide notice of rejection of a request unless requested to do so by the applicant.
- In case of a rejection of your application, Ukrainian Credit Union Limited is not obligated to provide the reason for the rejection.

- 5. Please make sure that you fill out the application that best fits your organization's needs
- Please ensure that you provide enough time for UCU to supply any required artwork such as logos for program booklets, signage, social media advertisement etc. It is not UCU's
  - responsibility to meet your timelines, it is your responsibility to ensure that we are properly acknowledged for supporting your project.
- If your organization is based in the Greater Hamilton Area including Hamilton-Wentworth, Grimsby and Burlington, your request will be directed to our Hamilton Advisory Committee and will be adjudicated by said committee.

#### **Restrictions specific to Category 2 donation requests**

## Category 2: concerts, anniversary events, large public events etc. - \$501 to \$2,500

If you represent a charitable or non-profit organization and are planning an event or project and have the time to apply for funding well in advance, this is the form you should fill out.

- For requests between \$501 and \$2,500.
- You must include a detailed application form and budget of your projected expenses and revenues associated with the project (including additional sponsor request information) please see the sample attached.
- 3. The application form should be submitted no less than three months (90) before the event.
- 4. If the request must be reviewed by the Donations Committee and then the Board of Directors, Ukrainian Credit Union Limited will provide an answer within 10-15 days following the decision of the Board of Directors (meetings usually held the 4th Thursday of each month).
- If the application is not submitted within the 90 requirement, it
  will automatically be downgraded to a Category 1 application
  and may be adjudicated according to the rules of Category 1
  up to a maximum amount of \$500.
- 6. Ukrainian Credit Union Limited will ONLY consider applications in this category that come from a recognized community group that is a registered charity or a non-profit organization. In extra-ordinary situations, non-members of the broader Ukrainian Canadian community may be considered for donations.
- 7. The organization must be either:
  - a. Ontario based and serve the local community in an area that is served by Ukrainian Credit Union Limited. This

- means that local community organizations of a general Canadian nature or of other ethnic groups that are served by Ukrainian Credit Union Limited may apply and be approved for a donation as long as they generally meet the other requirements of the application process.
- b. Canada-wide or global Ukrainian organizations may apply for Category 2 grants as long as they maintain an active account at Ukrainian Credit Union Limited.
- c. Ukrainian organizations based in Ukraine, Poland and other countries with significant Ukrainian populations may also apply even if they do not maintain an account at Ukrainian Credit Union Limited, however, they will be considered for an award of a donation ONLY if there is room in the ANNUAL budget after money has been disbursed to local and Canadian organizations.
- d. Major Canadian charitable organizations such as hospitals, foundations engaged in battling major diseases, food banks, etc. may also be considered for category 2 donations without the membership requirements.
- 8. The organization should be a member in good standing at Ukrainian Credit Union Limited.
- Organizations that maintain their accounts at other financial institutions are strongly encouraged to submit their request to those financial institutions rather than to Ukrainian Credit Union Limited.
- 10. Applications from individuals will generally not be accepted in this category, nor will applications generally, from for-profit organizations.
